Resolution 2018-70 Acquistion of Community Center

WHEREAS, by resolution dated February 9, 2016, the Town Board unanimously approved the acquisition of the former Oswego Center Methodist Church, which was converted into a Town Community Center; and

WHEREAS, the money utilized to purchase the Community Center, totaling \$40,000, was authorized to be taken from a capital reserve fund to be known as the 'Community Hall Capital Reserve Fund'; established in accordance with Section 6-c of the General Municipal Law; and

WHEREAS, the balance owed for the acquisition of the Community Center is \$20,000; and

WHEREAS, the Town Board deems it in the best interests of the Town to pay the balance due at this time from the capital reserve fund utilized to acquire and pay for a Town Community Center;

NOW, THEREFORE, on motion made by Councilor Tesoriero, and seconded by Supervisor Kaulfuss, BE IT RESOLVED as follows:

- 1. That the Town Board authorized the final payment of \$20,000 to be utilized from the Community Hall Capital Reserve Fund to pay for the acquisition of the Town Community Center.
- 2. The Town Supervisor is hereby directed to utilize moneys from the reserve fund to pay the final amount due for the acquisition of the Town Community Center.

Resolution 2018-73 Bond Financing for Rathburn Road Bridge Repairs

WHEREAS, by resolution dated April 11, 2017, the Town Board approved the bonding for the construction of a bridge over Rathburn Road in the Town of Oswego; and

WHEREAS, the bond resolution was subject to permissive referendum and the applicable period of time lapsed without a petition having been filed calling for a referendum, and the Town complied with all aspects of the Local Finance Law with respect to the publication of notices in relation to this matter; and

WHEREAS, the Town Board now desires to proceed with the bridge construction project and is seeking the assistance of Fiscal Advisors & Marketing, Inc. (Fiscal Advisors) to sale the qualified tax-exempt obligations by marketing the bonds to financial institutions who will bid on the issuance of the bonds; and

WHEREAS, Fiscal Advisors has prepared a Notice of Sale on behalf of the Town of Oswego for the \$200,000 Bond Anticipate Notes to be utilized to finance the bridge construction and such notice requires the Town Supervisor to sign the Notice and proceed with the conduct of the bidding procedure; and

WHEREAS, the Town Board deems it in the best interests of the Town to proceed with the Notice of Sale as the construction of a new bridge over Rathburn Road is at a critical point at this time;

NOW, THEREFORE, on motion made by Councilor Mahaney, and seconded by Councilor Herrmann, **BE IT RESOLVED** as follows:

- 1. That the Town Board approves the Notice of Sale for the \$200,000 Bond Anticipation Notes to be used to fund the cost of the bridge construction project for Rathburn Road.
- 2. The Town Supervisor is hereby authorized to sign the Notice of Sale and assist Fiscal Advisors, together with the Town's Bond Counsel, Barclay Damon, LLP with the conduct of the sale and all follow-up requirements needed to complete the bonding requirements for the construction of the Rathburn Road bridge, including the execution of all closing documents required to effectuate this bond financing.
