## **SEQRA RESOLUTION**

### **Declaring the Town of Oswego Town Board Lead Agency And Project as an Unlisted Action**

#### **REDI PROJECTS # 38 & 91**

**WHEREAS**, the Town Board for the Town of Oswego is the recipient of a Resiliency and Economic Development Initiative (REDI) grant for upgrades to both Lakeshore Road and West Lake Road; and

**WHEREAS**, the Town Board authorized the preparation of a Preliminary Engineering Report (PER) by BCA Architects & Engineers, and dated February 2020; to wit for Lakeshore Road (REDI Project #38): the proposed action includes improvements at the road, the proposed road improvements include road reconstruction and raising the elevation of the road in low-lying areas, and possible includes replacing three culverts under the road, if determined to be necessary during design; and for West Lake Road (REDI Project #91): the proposed action includes improvements at the road and at the shore of Lake Ontario at the outfall. The proposed improvements at the road include replacing and/or improving culverts under the road, road reconstruction and increasing the road elevation. The proposed improvements at the shoreline outfall include re-grading around and reinforcing of the existing outfall & adjacent shoreline with permanent structures (collectively, the Projects); and

**WHEREAS**, the Town Board for the Town of Oswego (the “Town Board”) has reviewed the PER and has determined that the Projects qualify as Unlisted Actions pursuant to the State Environmental Quality Review Act (SEQRA); and

**WHEREAS**, the Town Board believes it to be in the best position to assume the role of Lead Agency under a coordinated review by several involved state and local agencies to ensure an efficient and thorough review of the issues of any environmental significance of the Projects;

**NOW, THEREFORE, BE IT RESOLVED THAT,**

- (1) The Town Board hereby declares its intention to act as Lead Agency for the purpose of a coordinated review of the Projects in accordance with SEQRA (6 NYCRR 617).
- (2) The Town Board hereby declares the Projects as Unlisted Actions in accordance with SEQRA (6 NYCRR 617.2).
- (3) The Town Board hereby identifies the following agencies as Involved Agencies in accordance with 6 NYCRR 617.6:

- (4) The Projects do not involve federal agencies.
- (5) Short Environmental Assessment Forms shall be prepared and submitted to all Involved Agencies prior to a determination of significance being made for the Project by the Town Board.
