Old Business:

Tom Iorizzo requested clarification on when a Special Permit is necessary.

New Business:

Kim and Ken Fox, 8283 State Route 104: looking to add a mulch bin and an additional 3300 foot structure to their current business. It was pointed out that construction had already been started. Attorney Kevin Caraccioli advised the steps that needed to be done in order to get Planning Board approval.

Judy Sabin Watson made a motion to declare the Town of Oswego Planning Board as Lead Agency with an unlisted action, second by Ernie Mears. All in favor no opposition, motion carried.

Ernie Mears made a motion to hold a Public Hearing May 17, 2021 for the addition as well as to forward all documentation to Oswego County as well as any other agency that needs to be notified, second by Judy Sabin Watson. All in favor, no opposition. Motion carried.

Discussion:

Supervisor Rick Kaulfuss updated the Board on various projects going on in the Town: changes to flood maps, RWRP meeting, creation of Google drive with important documentation, 2 year moratorium on applying for retail sale and public consumption of marijuana.

Fran Dellamano discussed issues about cleaning streams so water can flow

Tom Iorizzo updated the Board on Zoning Law reviews: hoping to present a plan in 6 months.

Ernie Mears expressed concern over an apartment house on State Route 104 with garbage all over. Fran

Dellamano made a motion to write a letter to owner regarding issue from Planning Board with Tom Iorizzo and Don Labarge signature, second by Ernie Mears. All in favor, no opposition. Motion carried. Kevin Caraccioli will coordinate with CEO Don Labarge.

Tom Iorizzo made a suggestion that the Town of Oswego increase solar permit application fees.
